Did you know?

Serious incident process

GGUK have updated their process for responding to serious incidents. If an accident or incident occurs at a Girlguiding event or meeting that requires emergency services - such as a life-changing injury or fatality - our new emergency health and safety line (0207 592 1828) must be contacted within 1 hour. Support is available 24/7. Please can all leaders/event coordinators add this to any risk assessments going forwards.

Digital Pilot - Girlguiding is improving volunteering through technology | Girlguiding

Surrey East is one of two counties in England that has been asked to help pilot a new digital tool that enables you to register your unit meeting on your phone, ipad or laptop. 36 leaders in Surrey East volunteered to support the pilot and a number are now actively part of a 100-unit trial and their feedback will influence its development going forwards.

Safe Space 3/safer guiding

It is still essential to have someone at **all** meetings with a valid safe space 3, or the full safer guiding completed since December 2024 when it was introduced. If you did safe space 1 and 2 previously, it will say on Go and the learning platform that you are compliant with safer guiding as required for your role, but if you didn't have safe space 3, you still don't! If you want to address this gap, please complete safer guiding on the learning platform. All girl facing roles must complete safer guiding.

Needs Supervision

Leaders/commissioners – have you noticed the new section on Go titled 'Needs Supervision'. Please check this for your unit and address the reason why any volunteers are in it. It may be because they have not completed the mandatory recruitment checks or training necessary for their role and may be at risk. It may also be because their role has expired, at which stage they should discuss with their commissioner whether to continue in the role or to explore another role.

Residential Event Notification (REN)

It's a busy time for units that are planning residentials. Please remember that you should submit your residential event notification (REN) via GO under event administration, initially **at least 12 weeks** before the event and the final details **4 weeks before the event**. This allows time for commissioners and advisers to review the plan, the risk assessment and ensure that all the compliance requirements are met for all participating volunteers (including aged 14+ young leaders and dofE volunteers).
